

## **Euronet Ranks Number 36 on FORTUNE's Annual List of 100 Fastest-Growing Companies**

(Nasdaq: EEFT), a leading electronic payments provider, ranked number 36 overall on FORTUNE's annual list of the 100 Fastest-Growing Companies for 2006. The Company also placed fifth in the revenue growth category with a three-year annualized growth rate of 89 percent.

According to the magazine, the 100 Fastest-Growing Companies list was based on three equally weighted factors: both profit and sales growth (for three years through the first quarter of 2006) and three-year total return to investors (through the second quarter of 2006). The overall rank is based on the sum of the three ranks.
