Ria Money Transfer Helps to Raise \$164,000 for TeletonUSA in Support of Children With Disabilities

Ria Opens Up Its National Network of More Than 10,000 Locations for Donation Collection

Company Pledges \$35,000 Corporate Donation to TeletonUSA
