



Euronet's e-pay Subsidiary Signs Exclusive Prepaid Agreement with Caltex Australia, Australia's Largest Petrol Convenience Retailer

The signing of Caltex Australia strengthens the position of Euronet's e-pay subsidiary in the electronic prepaid market in Australia. e-pay anticipates the roll out process to be completed by mid-July to all participating Caltex convenience stores.

Their national service station network includes the largest number of convenience stores in Australia.
